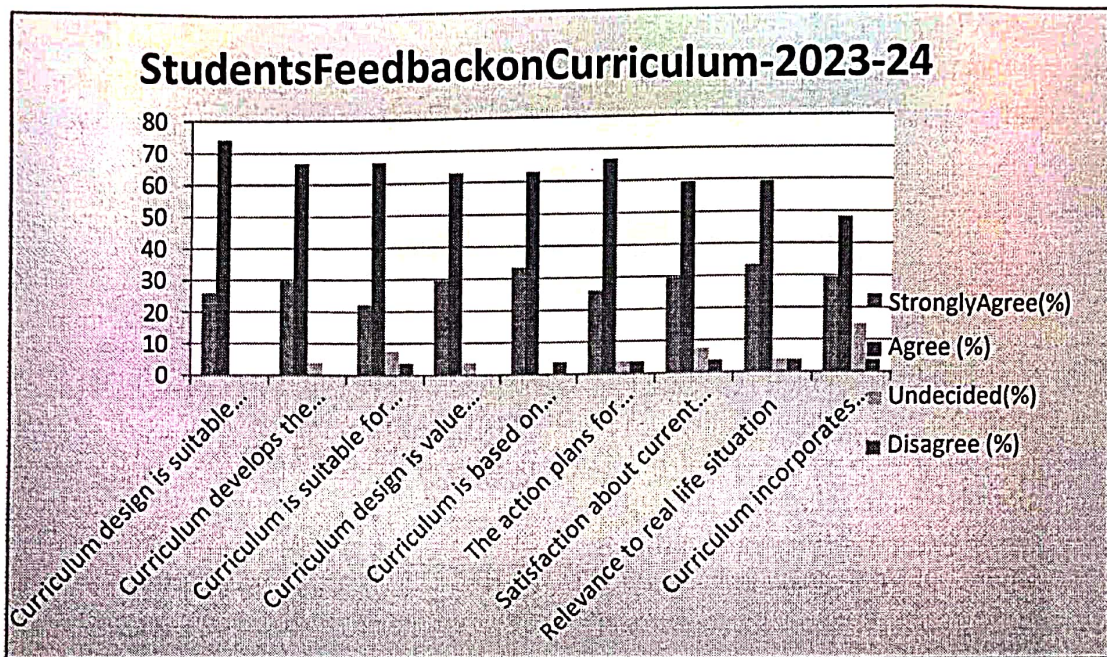

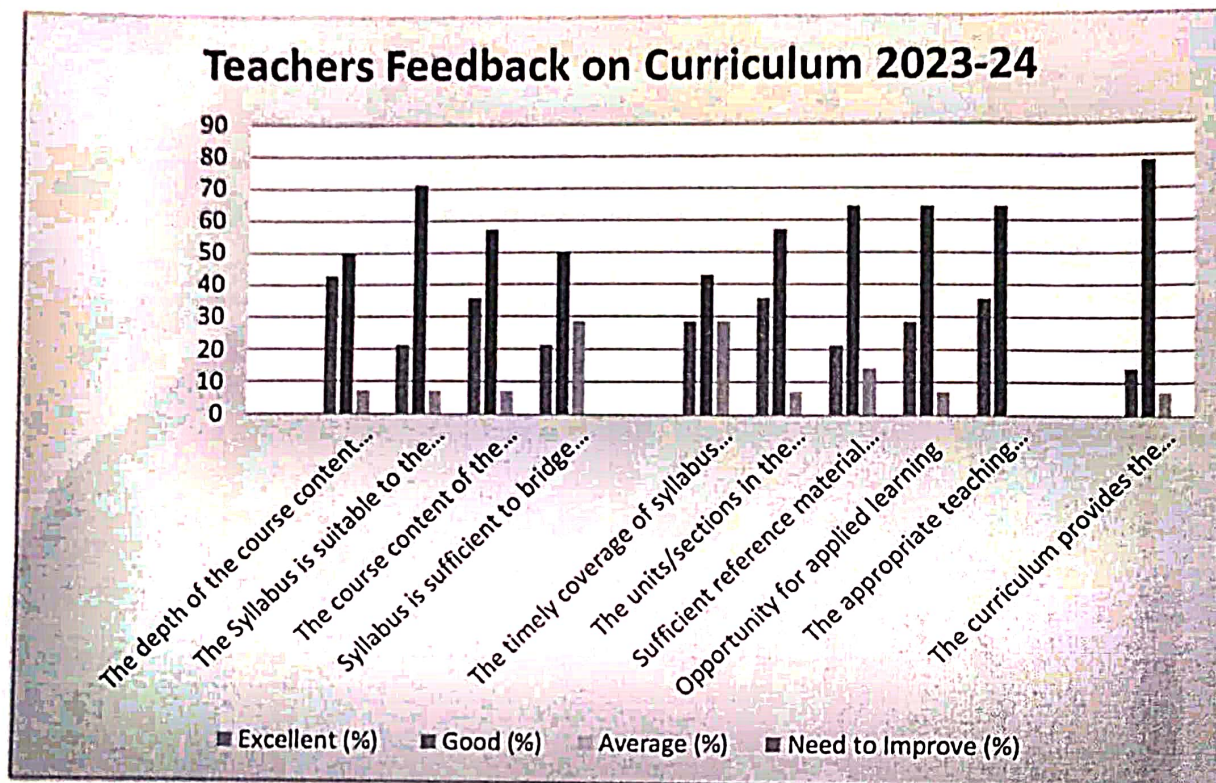
The curriculum evaluation survey reveals generally positive feedback, with most respondents agreeing that the curriculum effectively support student development and aligns with both regional and national needs. A majority (74.1%) believes the curriculum is suitable for the overall development of students, and similarly, most respondents feel it fosters global competence (66.7%) and is relevant to real-life situations (92.6%). The curriculum's value-based design also received favorable responses, with (63%) agreeing it incorporates ethical principles. However, while (66.7%) find the curriculum suitable for employability, there is a slight divergence, with a few respondents either undecided or dissatisfied (7.4% and 3.7%, respectively). Similarly, while most find the action plans for implementation satisfactory (66.7%), there is some minor dissatisfaction (7.4%). The survey also shows a good level of satisfaction with the current syllabus (59.3% agree), though a small percentage remains undecided or dissatisfied. The incorporation of recent changes to the curriculum received more mixed feedback, with (14.8%) undecided and (0%) disagreeing. In conclusion, while the curriculum is largely seen as effective and relevant, there are areas, particularly employability and the incorporation of recent updates, that could benefit from further improvement to ensure it meets the evolving needs of students and the job market.

Most respondents (92.9%) find the depth of the content adequate for significant learning outcomes. The syllabus is considered highly suitable for the course by 92.8% of respondents. 92.8% of respondents feel the course content improves students' knowledge and perspectives. Half of the respondents think the syllabus is good in bridging the gap with industry standards and global scenarios, though 28.6% believe improvement is needed. While 71.5% think the syllabus can be covered in the given hours, 28.5% feel the time allocated is insufficient. 92.8% believe the syllabus units are properly sequenced. Most respondents (85.7%) find sufficient reference materials available for the topics, though 14.3% consider it average. 92.9% agree there are good opportunities for applied learning in the curriculum. 100% of respondents believe the curriculum effectively incorporates appropriate teaching methods and ICT. 92.9% feel the curriculum allows flexibility for adapting new teaching methods.

In summary, the curriculum is generally rated highly, with some areas for improvement, especially regarding its alignment with industry standards and the time allocated for syllabus coverage.

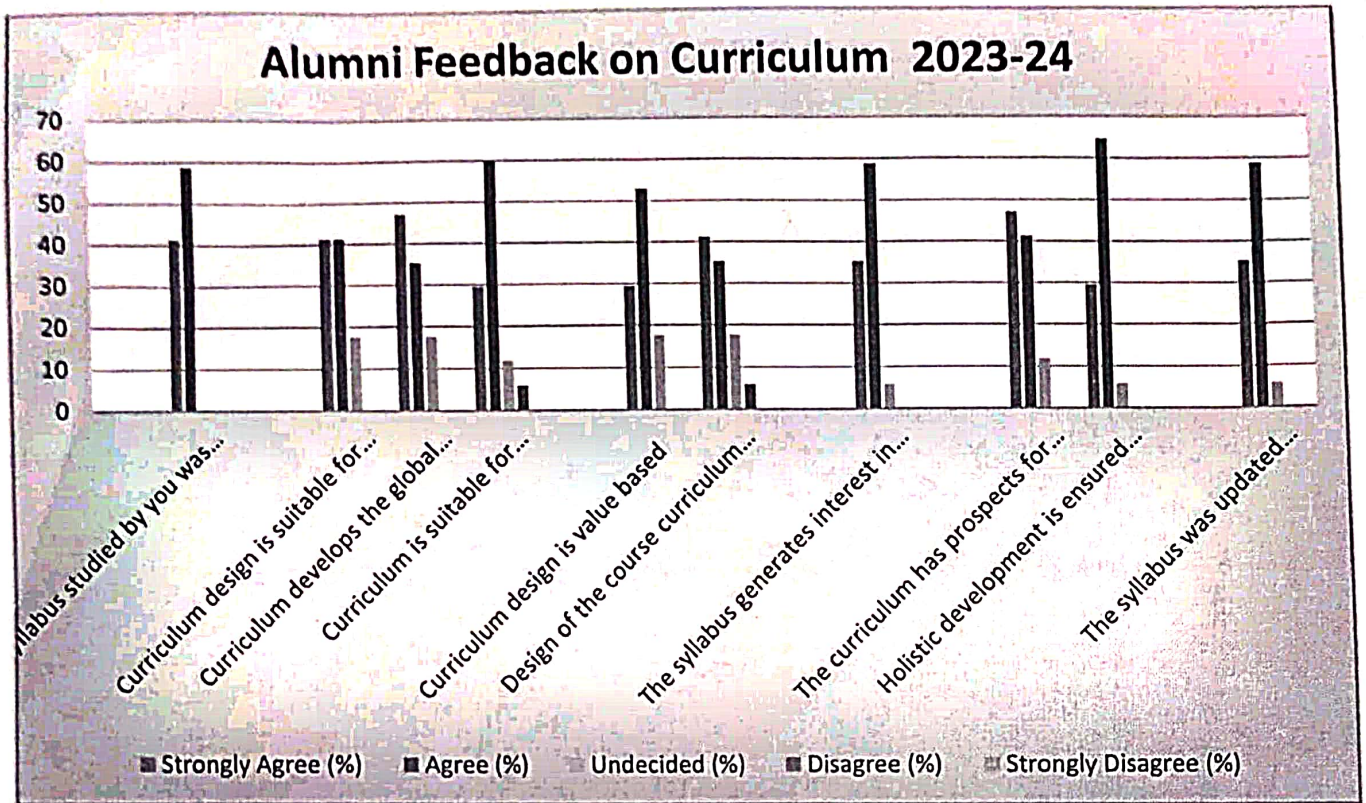

100% of respondents felt that the syllabus was relevant to their careers, with 41.2% strongly agreeing. 82.4% of respondents agreed that the curriculum design supports overall student development, with 41.2% strongly agreeing. 82.4% agreed that the curriculum develops global competence, with 47.1% strongly agreeing. 89.3% agreed the curriculum is suitable for current employability, though 5.9% disagreed. 82.3% felt the curriculum is value-based, with 52.9% agreeing and 29.4% strongly agreeing. 76.5% agreed that the curriculum encourages extra or self-learning, with 41.2% strongly agreeing. 94.1% agreed that the syllabus generates interest in the subject, with the majority strongly agreeing. 88.3% agreed the curriculum offers prospects for higher education or employability, with 47.1% strongly agreeing. 94.1% agreed the curriculum ensures holistic development, with 64.7% strongly agreeing. 94.1% agreed that the syllabus was updated to match recent trends, with 35.3% strongly agreeing.

Overall, the survey shows a high level of agreement among respondents, indicating satisfaction with the curriculum's relevance, design, and impact on employability, professional life, and holistic development.

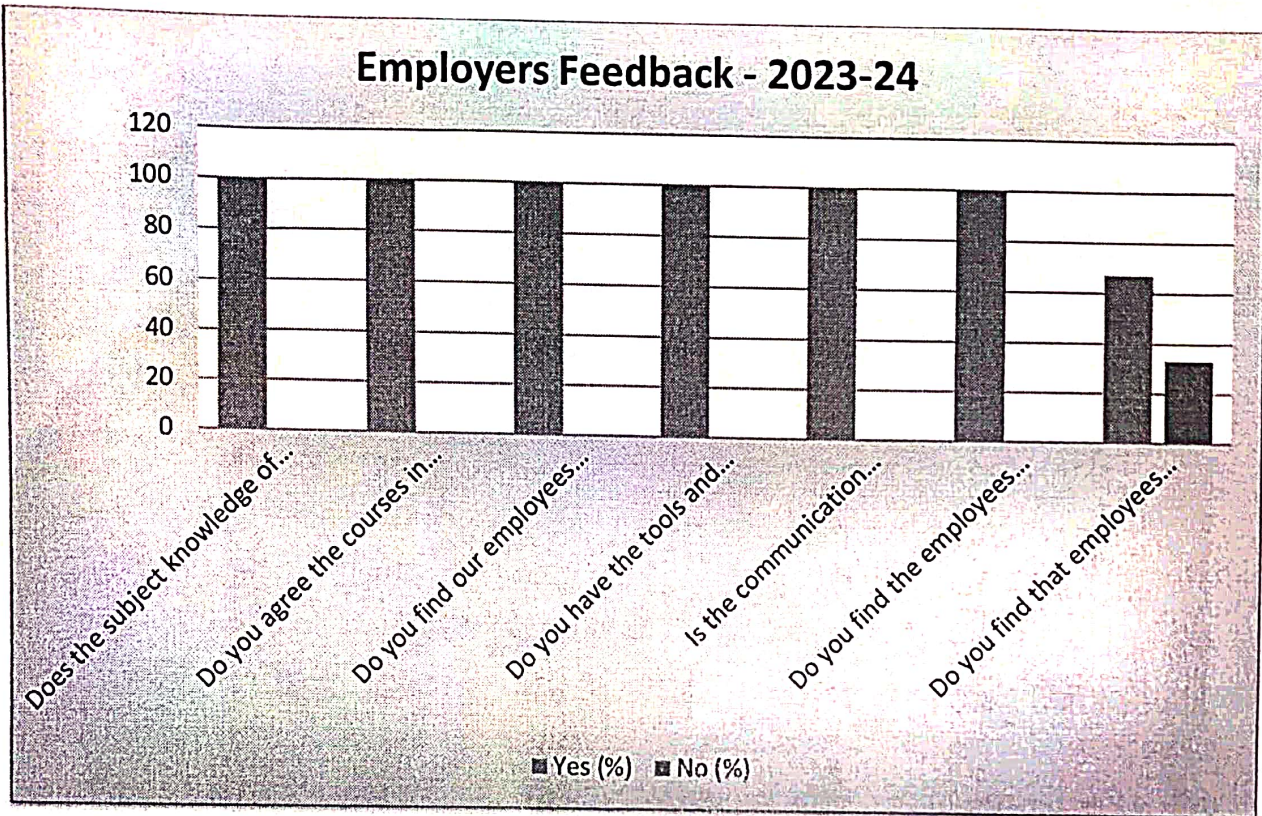
